This also includes the amount of the deposit and the expiration date for it. The payment plan should also indicate how and when the remaining amount is to be paid by the purchaser, e.g. monthly, weekly or discounted payoff. Late Fees Late fees are the fees applicable in the event of default by the purchaser. If the parties decide to include fees for arrears in the agreement, this should be mentioned in the agreement.
